

ROAD CONDITION REPORT FOR
PRECINCT NO. 3 OF WILSON COUNTY, TEXAS

Pursuant to Sections 251.005 and 251.018 of the Texas Transportation Code and other authority, the following Road Condition Report for Precinct No. 3 of Wilson County, Texas is submitted to the Commissioners Court of Wilson County, Texas for review and approval:


- (1) Singular nouns and pronouns shall include the plural, and the masculine gender shall include the feminine gender, where necessary for a correct meaning of this report.
- (2) All statements made in the preliminary recitals of this report, and all documents attached to this report as the Appendix, are true, correct, and incorporated by reference.
- (3) These terms have the following meanings for purposes of this report:
 - (a) "Commissioners Court" shall mean the Commissioners Court of Wilson County, Texas;
 - (b) "Contract," shall have the meaning defined by Section 251.005(c) of the Texas Transportation Code regarding a contract (i) made by the Commissioners Court since the date of the last report for any work on any road in the Precinct, and (ii) that must be submitted with this report.
 - (c) "County" shall mean Wilson County, Texas;
 - (d) "Precinct" shall mean the Commissioner Precinct of the County identified above.
 - (e) "Degradation" shall mean damage reasonably identified and ascertained by the County's elected or appointed officials, staff, employees, or representatives to have been caused to a public road, bridge, or culvert. Degradation or damage identified as having been caused by oil or gas exploration, oil related traffic, oil field traffic, gravel or vacuum truck traffic, oil rig traffic, overweight trucks, or similar phrasing related to oil or gas industry activities shall mean degradation primarily caused by traffic from the exploration, production, or development of oil or gas;
 - (f) "Public road, bridge, or culvert" shall mean the traveled portion of a public road as well as the public bridges, culverts, drainage ditches, and bar ditches that are adjacent or connected to said road -- but shall not include state or federal highways, or the

public transportation infrastructure adjacent or connected thereto, unless otherwise designated; and

(g) "Report" shall mean this report unless otherwise designated.


- (4) This report is submitted for the following period: Oct 2018 – Sept 2019.
- (5) The current condition of each public road, bridge, and culvert in this Precinct, and the primary cause of any degradation thereto, are identified as follows: as described in the attached Appendix.
- (6) The amount of money necessary for the maintenance of the public roads, bridges, and culverts this Precinct during the next fiscal year is identified as follows: a total of \$2,144,00.00 and as further described in the attached Appendix.
