***Variance/Non-Standard Plat	\$500.00
• Plus Drainage Review fee, if applicable	\$500.00
Amend a Plat	\$200.00
Revise a Plat (Re-Plat)	\$100.00/lot created + all publication costs
• Plus Drainage Review fee, if applicable	\$500.00
Cancel a Plat	\$100.00/lot created + all publication costs

PIPROW Permit Applications:

▪ Temporary/Construction Driveway	\$100.00 (credited to permanent)
▪ Residential & Agriculture Driveway	\$250.00 (min 12 ft/ max 24 ft)
▪ Commercial Driveway	\$750.00 (min 24 ft/max 100 ft. - over 100 ft is an additional \$750.00)
❖ Temporary Advertising Sign	\$25.00
❖ Private Improvement	\$50.00

OSSF permit applications:

▪ Single family residence, not requiring a design, and not in platted subdivisions	\$250.00
▪ Single family residence w/conventional system*, or design required, or in platted subdivision	\$350.00
▪ All others (commercial or alternative systems**)	\$400.00

*Conventional systems include but are not limited to pipe and gravel; gravel less pipe; multi-pipe system; and leaching chambers.

**Alternative systems include but are not limited to aerobic; low pressure dosing; lined and unlined ET; and drip irrigation.
